	(iii)	The real estate agent shall not involve himself in any unfair trade practices as specified under clause (c) of section 10		
		of the Real Estate (Regulation & Development) Act, 2016;		
	(iv)	The real estate agent shall provide assistance to enable the allottee and promoter to exercise their respective rights		
		and fulfil their respective obligations at the time of booking and sale of any plot, apartment or building, as the case		
		may be.		
	(v)	The real estate agent shall comply with the provisions of the Real Estate (Regulation & Development) Act, 2016 and		
		the Karnataka Real Estate (Regulation & Development) Rules, 2017 and regulations made thereunder;		
	(vi)	The real estate agent shall not contravene the provisions of any other law for the time being in force in the area where		
		the project is being developed;
